Regalo promises to begin pressing the delivered olives within 24 hours of receipt.

As olive oil yield is dependent on many factors outside our control, **Regalo** cannot guarantee any particular yield of olive oil.

The submitting party agrees to pick up their olive oil within 24 hours of notification of completion of pressing. Oil left more than 48 hrs after notification may become the property of **Regalo**.

If the submitting party provides their own containers they must be clean and in good order. If not, **Regalo** will obtain new containers at the expense of the submitting party. The charge for containers supplied by **Regalo** will be cost + 30%.

Pressing charges: \$450 / ton. For small lots: \$1.00 / lb; \$400 minimum charge.

Limitations:

Regalo will not be held responsible for pressing delays or inefficiencies due to equipment failure and / or repair. **Regalo** certifies that in the event of equipment failure every effort to effect repair and resuming pressing in a timely fashion will be made. In the event that timely pressing cannot resume, **Regalo** will assist you in locating alternative pressing services and **Regalo** pressing charges will be pro rated according to the job completed by **Regalo**. Transport of unprocessed olives to an alternate pressing service will be the responsibility of the submitting grower.
